Fees for Academic Year 2025/2026

Termly fees

Vaud public school package - 19 lessons per term following public Vaud school holidays, fee includes participation in all student events:

- 30 minutes – 825 CHF
- 45 minutes – 1230 CHF
- 60 minutes – 1620 CHF

General package (recommended for adults & students at international schools) - 15 lessons per term not following specific holidays, fee incl. participation in all events:

- 30 minutes – 795 CHF
- 45 minutes – 1165 CHF
- 60 minutes – 1545 CHF

Entry in the middle of the respective terms is possible. In this case, the lessons missed due to late entry will be deducted off the termly fee. Bundles are invoiced at the start and middle of the term (50% each time) respectively.

Reductions on termly fees:

- 5% reduction is granted on the **second child** from same family
- **Bursary contributions and partial to full discounts** are available through our academies' charity AJMC – please discuss with director directly.

Trial lessons

- All students have the opportunity to undertake a **free, non-binding first trial lesson** with their teacher. This must not be confused with a single lesson (see below).

Single lessons

Single lessons can be undertaken for students who wish to not commit to a term. The lesson fee is billed by the school to the student after the lesson and is deducted from the termly fee if the student wishes to continue. No reductions can be granted on single lessons.

Private Trial lesson fee:

- 30 minutes – 55 CHF
- 45 minutes – 75 CHF
- 60 minutes – 95 CHF

Key information for the 2025/2026 school year

Key dates

- Term 1 2025/2026: 18. August 2025 – 25. January 2026
- Term 2 2025/2026: 26. January 2026 – 28. June 2026
- Event Dates: March 2026 (student recital), June 2026 (student recital). Dates are both to be confirmed

Terms and Conditions

- These terms and conditions are automatically applied to all students signed up at the academy, and can be found on our website.
 - 1) Termly packages are billed by the academy at the start and middle of each term respectively, and are to be paid within 30 days.
 - 2) Sign-ups are valid for the whole term, and refunds for exits halfway through the term cannot usually be granted.
 - 3) The student is automatically reregistered for the following term if they do not abide by the school cancellation period. The last day of the cancellation periods for the academic year 2025/2026 are 30. November 2025 and 31. May 2026 respectively. Failure to deregister by those dates may lead to the student still being liable to pay the full fee for the subsequent term.
 - 4) At the start of each term, each student will receive a pre-scheduled weekly lesson time with their teacher. Changes to this timing slot must be agreed with their teacher, and failure to attend this slot cannot result in refunds, and it is up to the teacher to decide whether to repeat this lesson or not.
 - 5) In case of illness of the teacher, either a substitute teacher will take over the lesson or the lesson will be repeated at a later date.
 - 6) Any changes to lesson length or teacher must be approved by the academy office in advance of occurring.
 - 7) The costs of instruments and learning material for the student are not included in any way by the term or trial fee.
